NEW DELHI: Opener I Rahul will be playing for India A in their first unofficial Test against England Lions to be held in Wayanad from February 7-10.

SPOT-FIXING

NEW DELHI: The Supreme Court Wednesday questioned the conduct of cricketer Sreesanth for not immediately bringing the alleged spot-fixing during the Indian Premier League (IPL) match in 2013.

The apex court observed that the conduct of Sreesanth, who is facing life ban for his alleged involvement in the sensational spot-fixing scandal, in the entire episode was "not good". Sreesanth, who was charged by a trial court in 2015 in a criminal case relating to alleged spot-fixing, a bench of Justices Ashok Bhushan and K M Joseph had imposed a life ban on him by the Board of Control for Cricket in India (BCCI) was harsh there was no evidence to substantiate the claim that he indulged in any illegality.

The 35-year-old cricketer has challenged in the court the decision of a bench of the Kerala High Court which restored the ban imposed on him.
