"So far, he is asked to turn up next Tuesday to enable us to record his statement relating to SRC International," Bernama quoted an MACC source as saying in the report issued late Friday. SRC International was a subsidiary of IMDB before being placed directly under the finance ministry in 2012.

Najib was both prime minister and finance minister at the time. Hundreds of millions of dollars linked to SRC are alleged to have gone missing, in just one component of the wide-ranging IMDB affair. AGENCIES
