पहली महिला वित्त मंत्री बनीं सीतारमण

निर्मला सीतारमण ने शुक्रवार को देश की पहली पूर्णकालिक महिला वित्त मंत्री बनकर एक बार फिर इतिहास रचा। वित्त मंत्री के तौर पर उन्हें आर्थिक नरमी, रोजगार सृजन, फंडेज को काबू में लाने और निवेश बढ़ाने की चुनौती से निपटना होगा।

सीतारमण ने इससे पहले भी इतिहास रचा जब उन्होंने प्रधानमंत्री नरेंद्र मोदी की भगुवाई वाली पिछली सरकार में पूर्णकालिक वित्त मंत्री का कार्यभार संभाला। मोदी सरकार के दूसरे कार्यकाल में अब वह वित्त मंत्रालय का जिम्मा संभालेंगी। यह पहला मौका है जब किसी महिला को पूर्णकालिक वित्त मंत्री नियुक्त किया गया है। इससे पहले, प्रधानमंत्री रहते थे इंदिरा गांधी ने 1970-71 में वित्त मंत्रालय का अतिरिक्त कार्यभार संभाला था। साठ साल की सीतारमण ने अरुण जेटली का स्थान लिया है। जेटली ने इस सप्ताह की शुरुआत में वित्त मंत्री को पत्र लिखकर कहा था कि वह स्वास्थ्य कारणों से मंत्री पद पर नहीं बने इना चाहते। उन्होंने ऐसे समय वित्त मंत्रालय का जिम्मा संभाला है जब अर्थव्यवस्था नरमी, निर्यात में गिरावट तथा फंडेज को काबू में लाने की समस्या से जूझ रही है।
