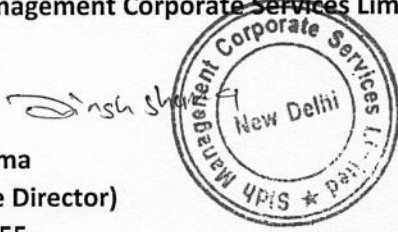

The listing application of 332367 Equity Shares(Which were issued and allotted on 13/08/2014 on conversion of convertible warrants) was made to the Delhi Stock Exchange on 24/09/2014. Later on SEBI de-recognised DSE vide order no. WTM/PS/45MRD/DSA/NOV/2014 dated 19/11/2014. Therefore, 332367 Equity Shares could not get listed on Delhi Stock Exchange. Consequently, these shares are not listed on Metropolitan Stock Exchange of India Limited.

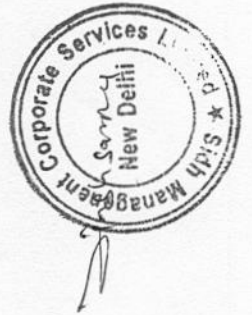
